Passive voluntary euthanasia is when no actions are taken to keep a person alive, like when a ventilator is removed or a feeding tube is not inserted. This is commonly done when a patient has experienced severe brain damage. When a person has been found to have severe brain damage or even to be brain dead, they are actually already gone.

Requirements for Animal Euthanasia. According to Health & Safety Code Chapter 821: Injectable sodium pentobarbital is the only form of euthanasia that may be used on dogs and cats in animal shelters. Anyone (except a veterinarian) who euthanizes animals in an animal shelter must be trained in proper procedures.
